## **Highlights of Provincial ASCD Advisor Activities:**

The first quarter of the 2014 fiscal year has been one of transition. Danielle Smith took a new position with MCFD's Early Years office in May 2014 and I stepped into the ASCD Provincial Advisor role on June 9<sup>th</sup> 2014. Despite there being a temporary lapse in the position, I have worked hard to try and "hit the ground running" and continue the many areas of work that Danielle was involved in. I am excited to bring my 16 years of working in various positions of Aboriginal Early Childhood Development to this leadership position. My passion for early childhood development is driven by a strong belief that Aboriginal children deserve the right to be supported to reach their fullest potential, with culturally safe early childhood programs, no matter where they reside in our province. I have sent out a formal letter of introduction to the programs, as well as a summer issue of the ASCD Connections e-newsletter. Coming into the position I have personally called all of the ASCD programs and ASCD Regional Advisors to further introduce myself and connect. It's been a wonderful couple of months in this position and I look forward to the year ahead.

One project of considerable importance is the Partnerships Project. The process of changing over the host agency for the Partnerships Project from the Comox Child Development Association to the BC Association of Aboriginal Friendship Centres has been completed. We want to thank Lorraine Aitken and Tanya Brown for all of their past work with the Partnerships project. The ASCD Provincial Advisor and the Provincial office will now oversee the Partnership Training in the province. Elaine Zamardi who is the Project Officer for the AIDP and ASCD Provincial office is now the new Partnership Coordinator.

Other priorities that have been concentrated on in this quarter has been advocating and seeking out funding for an AIDP and ASCD Provincial In-service, sharing ASCD data collection information, transitioning the new ASCD Provincial Advisor into office, meeting and emails to MCFD and the Assistant Deputy Minister seeking support for AIDP and ASCD programs ongoing challenges and support for ASCD policy development. Although MCFD, Assistant Deputy Minister, Randy Mjolsness and Dena Carroll (Director - Aboriginal Policy and Legislative Team), are supportive of the idea of policy development, a funding request of \$30,000 from the AIDP and ASCD Provincial office to MCFD for the 2014/15 year for ASCD policy development was unfortunately not provided. Currently the Provincial Office has no funding resources to complete this project, however preliminary work is moving forward regardless. The Provincial Office will continue conversations with MCFD for support on this project.

The Provincial AIDP and ASCD Provincial office has been working to organize an AIDP and ASCD Provincial in-service for April 2015. We are sad to inform the Province and the IDP/AIDP and SCD/ASCD programs that due to lack of funding, the Provincial office is unable to organize a provincial training for 2015. The previous ASCD Provincial Advisor had submitted a proposal to MCFD's Aboriginal Services Innovations- Early Years proposal call in May 2014, but our office was unsuccessful as the funding was targeted for "direct service delivery." This is an area that the AIDP and ASCD Provincial office will be continuing to advocate for. The need for ongoing professional development in the field is crucial for our early intervention programs to provide quality services to the most vulnerable population in our province; children with special needs. Regional and agency funds for professional development remain limited; as well the IDP/AIDP and SCD/ASCD Professional Development fund will be depleted in approximately 18 months. Staff turnover in the field, as well as

MCFD's recent funding given to "new" and "emerging" AECD programs again makes it critical that they support ongoing professional development in our specialized field.

Within ASCD, a variety of activities were completed included continued participation in various committees, assistance in the development of protocol agreements between non-aboriginal programs and Aboriginal AIDP/ASCD. The ASCD Information Gathering Questionnaire and data collection process was completed in the last quarter. 35% of ASCD programs reported back and I will be looking to connect with the remaining programs to assist them with providing information. A report summarizing the gathered information was made available to the Steering Committee and programs at the end of the March 2014.

The following are updates from the various committees Danielle and I have participated on:



### **Committee Updates:**

#### **Professional Development Fund:**

The Professional Development Fund Committee continues to meet and is realizing how limited this resource base is. Currently there is just over \$125,000 remaining in this fund and will be exhausted within the next 18 months. The Committee is considering options for enhancing this fund and we continue to encourage ASCD programs to continue to access this opportunity to assist with professional development costs.

The Provincial AIDP and ASCD program and Liz Cox (Professional Development Fund) have put together a briefing note and will be meeting with MCFD, Assistant Deputy Minister, Randy Mjolsness and Dena Carroll (Director - Aboriginal Policy and Legislative Team) on September 25<sup>th</sup> 2014 in Victoria to discuss the depleting Professional Development Funds. As well, a letter from the AIDP and ASCD Provincial office has gone out to the IDP/AIDP and SCD/ASCD Regional Advisors asking for input and assistance on how best to spend the remaining Professional Development Funds. Within this funding pot there is \$60,000 specifically earmarked for curriculum development. We hope to get input from the Regional Advisors at the next face to face meeting Sept 22<sup>nd</sup> in Vancouver before our next Professional Development Fund committee meeting and the Sept 25<sup>th</sup> meeting in Victoria.

#### **Partnerships Project:**

The process of changing over the host agency for the Partnerships Project from the Comox Child Development Association to the BC Association of Aboriginal Friendship Centres has been completed. The ASCD Provincial Advisor and the Provincial office will now oversee the Partnership Training in the province. Elaine Zamardi who is the Project Officer for the AIDP and ASCD Provincial office is now the new Partnership Coordinator.

Elaine Zamardi the Partnership Coordinator organized a very successful partnership training in Terrace in May 2014 in three of the Partnership Modules. The Provincial office is pleased to accept the responsibility of this important training initiative and will work to uphold the integrity of this training project. There are approx. 7 Partnership training requests from various areas of the province and we will be looking at facilitating some of these training in the fall of 2014 in the Lower Mainland and possibly the Interior region.

#### **Maternal Child and Family Health Committee:**

I was able to participate on this Committee Conference Call on behalf of Diana Elliot and the AIDP and ASCD Provincial office. The Maternal Child and Family Health Committee will be providing a representative to the AIDP and ASCD Provincial Steering Committee. Diana Elliot will sit on their committee to ensure continued partnerships and collaboration between AIDP,

ASCD and Maternal Child and Family Health. I have begun working with a representative from the First Nations Health Authority to map out ASCD, AIDP and Maternal Child Health programs on-reserve in the province.

#### FOPP:

The finalized FOPP document was distributed in the last couple of months to IDP/AIDP and SCD/ASCD. There have been no FOPP meetings within this fiscal reporting period

#### Assessment Working Group:

The Assessment working group had a teleconference on June 19<sup>th</sup> 2014. Currently there are a number of IDP and SCD programs piloting one or two of the six identified assessment/screening tools identified by MCFD (Battelle, Brigance, DAYC2, ASQ, ASQ-SE and AEPS). The interior region is completing a collaborative pilot project with the Brigance and DAYC2. The Fraser region hosted three – one day DAYC orientation sessions that was well attended by IDP/AIDP and SCD/ASCD. There is no formal training for the DAYC but Michaela Wooldridge from Surrey IDP has put together a one day learning session on DAYC and will be organizing a DAYC orientation for the Interior in the Fall. At this time there is no funding from MCFD to support assessment training in the tools identified and programs are looking at grandfathering out the Gessell assessment in the next year. The Provincial and Regional Advisors for both IDP/AIDP and SCD/ASCD will need to be creative and collaborate and share resources for the ongoing training in these tools. As well, we will all need to advocate to MCFD for funding to support ongoing professional development in these assessment tools to ensure quality “best practices” in assessment and screening. The assessment committee has created an assessment feedback form to document pilot projects.

#### International Indigenous Early Childhood Development Conference Planning Committee

The IIECE Conference is set for July 18<sup>th</sup> – 23<sup>rd</sup> 2016 in Victoria on the Songheas First Nations territory. Initial planning and fundraising has started. At this time there is no secured funding to support this event. I have started working on a funding proposal request to Scotia Bank for \$10,000 each year over 2 years to support this conference and will submit it on behalf of the AIDP and ASCD Provincial office in August 2014.

#### Training Opportunity:

Diana and I attended the Interior Region In-service in Kamloops at the end of May 2014. I was able to provide feedback to the Interior regional advisors on the planning and facilitation of it. Diana and I will also be attending the Vancouver Island In-service on Oct 3<sup>rd</sup> 2014 to give a provincial update, as well as attending the Northern region In-service Oct 6<sup>th</sup>-8<sup>th</sup> in Prince George. I will also be arranging to finish facilitating 3 sessions of Partnership training in New Aiyansh in the early fall on “Positive Approaches to Behaviour.”
